### Cameron Engineers, Inc. Collection

#### Background Information

#### Cameron Engineers, Inc.

Cameron Engineers, Inc., a Colorado engineering firm, began as Cameron and Jones, Inc., as a partnership between Russell J. Cameron and John B. Jones, Jr., two veterans of the U.S. Bureau of Mines Research at Anvil Points in the early 1950s. The firm later became Pace Engineering, Inc.

Although the firm began in oil shale engineering and directed most of its efforts towards oil shale development in Colorado and Brazil, the firm offered general engineering services throughout the Rocky Mountain region.

#### Cameron Engineers Collection

The Cameron Engineers Collection spans the three companies from 1965 to 1982. The collection contains three unique sets of documents that comprise more than half of the collection. They are: (1), a complete collection of the U.S. Bureau of Mines Intra-bureau Reports detailing the oil shale research carried out at Anvil Points from the late 1940s to the late 1950s; (2), the Synthetic Fuels Quarterly Report, published by Cameron Engineers and the predecessor and successor companies; (3), Oil Shale and Related Fuels Quarterly Report published by Cameron and Jones, Inc.
